- Formal collaboration with partner organisations on joint venture activities

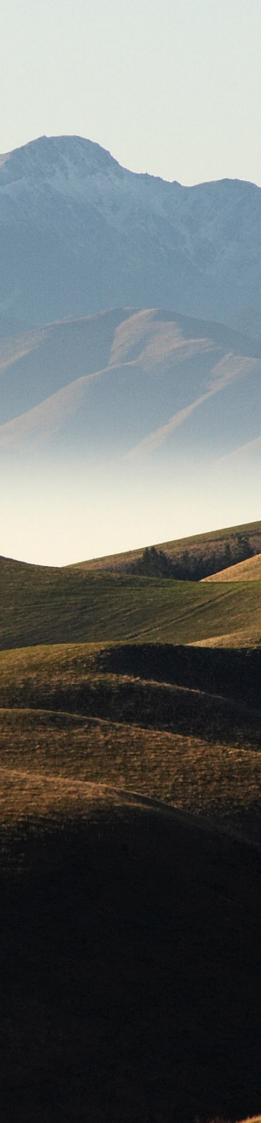

We have some major plans to mark this occasion, with events throughout New Zealand, culminating in a conference dinner and birthday celebration at the Air Force Museum of New Zealand. From a finance perspective, in line with member feedback, we have endeavoured to ensure the organisation is future-proofed, while also minimising any increase in membership and event fees. This means that we are now running a much lower level of annual surplus, and instead reinvesting funds in member support and research activities.

As always, I'd like to emphasise that WasteMINZ is your organisation. The Board and I are here to represent the interests of the sector as a whole and to advance the conversation in the areas of waste management, resource recovery and contaminated land. We welcome your feedback on how we can add more value for you.





Our year in review

Behaviour Change

A full update of the New Zealand Recycling Symbols was undertaken; they are now available to download free-of-charge from the WasteMINZ website.

After significant feedback from the sector, it was identified that there was a need to translate the symbols into Te Reo Maori, as well creating standardised translations for waste and recycling signage. This work is currently underway, and due to be completed in late 2017.

A second signage project was also undertaken. This involved creating a detailed fact sheet for councils and organisations looking to create signage for zero waste events. The factsheet outlines the key considerations when creating signage and provides examples of effective signage in use around the country.

Love Food Hate Waste

We're now midway through the Love Food Hate Waste campaign, and it continues to go from strength to strength.

With "Love Your Leftovers" the campaign theme for the year, there was a concentrated focus on leftovers in November 2016, which included an array of cooking videos showing different ways to use leftovers and culminated in a national "Love Your Leftovers" day. This was supported by Auckland Council who created a Love Food Hate Waste fund to encourage community groups to organise food waste minimisation activities in the region.

In December 2016 the campaign opened New Zealand's first community fridge in Auckland. The fridge allowed people and businesses to donate their excess food while providing food for those in need. The community fridge launch received significant media coverage. The fridge was initially envisioned as a three-week media activation. However, it proved so popular it has now become a permanent fixture and inspired a member of the public to create their own community fridge in Christchurch.

The University of Otago continued as our research partner. The campaign funded a summer scholarship to test different food storage methods. This research provided best practice recommendations on how to store food such as bread, cheese, avocados and lettuce. This research was well received by the public and was picked up by NewsHub, the NZ Herald, and a range of other media outlets.

Councils have also been delivering an array of activations in their local areas in support of the campaign.

The increased awareness of food waste has seen further momentum from the sector. Countdown supermarkets continue to support the campaign, and in February they introduced "The Odd Bunch" a range of misshapen fruit and vegetables at competitive prices. Countdown has also renewed their partnership with food rescue groups around the country, and we have seen another three food rescue organisations set up, in Hastings, Christchurch and Nelson.

TA Forum

This year saw a concerted effort by councils around the country to push for a levy on single-use plastic bags.

Spearheaded by Mayor Justin Lester,

90% of mayors from around the country called for a compulsory levy on plastic bags. Research commissioned by the TA Forum provided solid evidence that the public was broadly supportive of bag charges. WasteMINZ also encouraged greater collaboration between councils and the community sector by connecting up community initiatives such as Boomerang Bags.

Understanding the potential implications of container deposit schemes for councils has also been a key focus of the TA Forum. Auckland Council and members of the TA Forum have worked closely together to understand what the impact of such a scheme would be on ratepayers.

Waste data

Following on from the development of the national waste data framework project a waste data working group was established to take forward key actions. A number of pieces of work have been undertaken, these include:

- Supporting a collective of Waikato and Bay of Plenty councils to develop standard bylaw clauses, licensing processes and confidentiality agreements pertinent to waste data. This work is now complete and the intention is that these same clauses and processes can be utilised throughout the country creating greater consistency.
- Developing and consulting on standard waste data reporting indicators for territorial authorities. This work is in the process of being finalised and is likely to be released in late 2017.

Organic Materials

A health and safety factsheet was created covering bioaerosols in composting operations. It highlights the risks associated with bioaerosols and suggests methods of control.

A successful application to the Environmental Protection Authority was made for grounds to have the status of clopyralid reassessed. The EPA agreed that grounds did exist. However, in subsequent meetings, it was made clear that even if further controls were implemented the EPA did not consider themselves to be in a position to effectively enforce them.

The Steering Committee provided feedback on the proposed changes to the Good Practice Guide for the Beneficial Use of Organic Waste Products on Land. In particular, the committee highlighted that the proposed urban soil zinc level was too low and would negatively impact on soil replacements made from compost blends compared to the 2003 guidelines.

Contaminated Land Management

A workshop was held at the conference in October 2016; Interpreting the changes to Guidelines 1 & 5, where key topics were presented and attendees worked through case studies in small groups. The workshop was very well-received with attendees noting it was very interactive, wellfacilitated, the case-studies were practical and the content of the workshop was interesting, varied and forward-thinking.

The Sector Group made a submission to the Ministry for the Environment on the proposed amendments to the National Environmental Standard for Assessing and Managing Contaminants in Soil to Protect Human Health. The updated standard is due to be released in early 2018.

A number of webinars were held throughout the year, which included NESCS reports – how to deliver what TAs expect, Benmore Pole 1 Deconstruction, Proposed amendments to the NES and ALARP and asbestos, a job for life?

The Steering Committee identified that graduates seemed to have very little understanding of the industry. They then contacted tertiary institutions throughout New Zealand, proposing that presentations be given to their students. Relevant content is currently being confirmed with the University of Auckland and presentations and site visits will be held in late 2017 and early 2018. Further discussions will be held with other tertiary institutions.

Health & Safety

The updates to the Health and Safety Guidelines: for the Solid Waste and Resource Recovery Sector – parts one, two, three, four and five, with the relevant principles from the Health and Safety at Work Act 2015 were completed in late 2016 and the updated guidelines were published on WasteMINZ' website in March 2017.

Collecting health and safety data from the waste industry for benchmarking purposes has been on the Steering Committee's agenda for some time. Seven parties have agreed to be part of a 12 month trial and a working group has now finalised the measures and definitions that will be used in the trial. An independent third party will be used to collate and aggregate the data and the trial should commence in early 2018.

A working group was formed to create good practice guidelines for waste collection operators when they are sharing the road with cyclists and collecting waste on cycle lanes. The guidelines will go out for consultation in early 2018.

Good practice guidelines to manage the collection, receipt, transport and disposal of asbestos waste, have been developed by a working group. The draft is currently with WorkSafe New Zealand, for their review. It will then go out for consultation, which is likely to be in early 2018.

Disposal to Land

WasteMINZ sent a survey to relevant parties in mid-2016 asking whether recipients supported the establishment of a disposal to land sector group, which would take an integrated approach to all types of disposal and the types of stakeholders that should be engaged with. The sector group was subsequently formed in late 2016 and has formulated their strategic plan and related work plan.

The first iteration of the Technical Guidelines for Disposal to Land was published on WasteMINZ' website in April 2016. Since that time, WasteMINZ has been working with the Ministry for the Environment and the Regional Waste and Contaminated Land Officers Forum on subsequent updates. These updates are currently being discussed and future actions are being identified.

In November 2016 a webinar on Leachate recirculation – an international and local perspective was held, which included a presentation by Simonne Eldridge from Tonkin + Taylor.

Notes to the Financial Statements

STATEMENT OF ACCOUNTING POLICIES

1 REPORTING ENTITY

The financial statements presented here are for the entity Waste Management Institute New Zealand Incorporated. Waste Management Institute New Zealand Incorporated is incorporated as a board under the Incorporated Societies Act. The Financial Statements of Waste Management Institute New Zealand Incorporated are General Purpose Financial Statements which have been prepared according to Generally Accepted Accounting Practice.

Waste Management Institute New Zealand Incorporated has adopted "Old New Zealand GAAP" with the application of New Zealand Financial Reporting Standards (FRS) and Statement of Standard Accountancy Practice (SSAP).

2 MEASUREMENT BASE

The accounting principles recognised as appropriate for the measurement and reporting of earnings and financial position on an historical cost basis have been used, with the exception of certain items for which specific accounting policies have been identified.

3 CHANGES IN ACCOUNTING POLICIES

There have been no changes in accounting policies. All policies have been applied on bases consistent with those used in previous years.

4 SPECIFIC ACCOUNTING POLICIES

The following specific accounting policies which materially affect the measurement of financial performance and the financial position, have been applied:

(a) Differential Reporting

Waste Management Institute New Zealand Incorporated is a qualifying entity in that it qualifies for Differential Reporting as it is not publicly accountable and there is no separation between the owners and the governing body.

All Differential Reporting exemptions have been applied.

(b) Fixed Assets & Depreciation

The entity has the following classes of fixed assets:

Office Equipment

Motor Vehicle

Land and Building

All fixed assets are initially recorded at cost with depreciation being deducted on all tangible fixed assets other than freehold land, in accordance with rates set out in the Income Tax Act 2007.

(c) Goods & Services Tax

The Statement of Financial Performance and Statement of Cash flows (where included) have been prepared so that all components are stated exclusive of GST. All items in the Statement of Financial Position are stated net of GST, with the exception of Accounts Receivables and Payables.

(d) Income Tax

A provision has been made for Fringe Benefit Tax Payable.

(e) Receivables

Receivables are stated at their estimated realisable value. Bad Debts are written off in the year in which they are identified.

(f) Investments

Investments are carried at the lower cost and net realisable value. Where in the opinion of the Board there has been a permanent reduction in the value of investments, this has been brought to account in the current period.

5 **OPERATIVE COMMITMENTS**

The society has an operating lease commitment with Fuji Xerox for three years. \$3,692.25 for 2016/2017 year.

6 **RELATED PARTY DISCLOSURES**

The governance of the society is not aware of any related party transactions requiring disclosure.
